

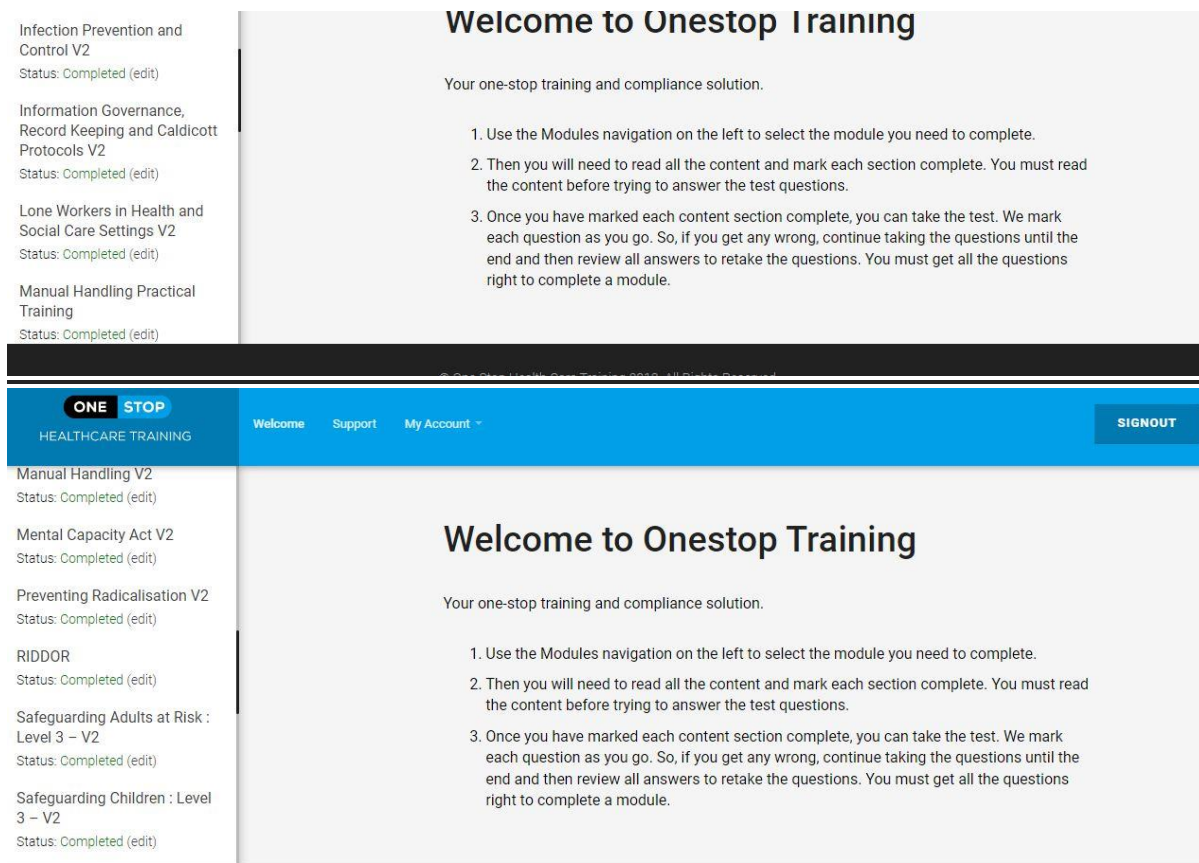
Annual Mandatory Training
