2.	Review of previous minutes and actions Minutes agreed. Outstanding actions: Prepare constitution vote for ASM Treasurer computer still to be purchased.

VS preferred one day. ? ask for some pre-recorded session from guest speakers. Ideas Covid session with link to vascular disease. Ask someone from COVER to talk. Would consist of some recorded material and possibly live with Q&A. Prof Greenhalgh has asked for SVT ultrasound session at Charing X Vienna which will also be virtual. HA asked if any preliminary findings available from SONAR trial run by Cambridge which ended 6 months ago. ? could one of the contributors present? Format for conference 4 hours session then if abstracts submitted add 2 hours on another day. Ask VS if can pre-record but show live and watch back later. But presenter logs on to answer questions. Looking to 2021 ASM, RS asked if there is a possibility of combining attended meeting with live streaming. Feedback from last conference submitted to EBS but not heard back.	СТ
