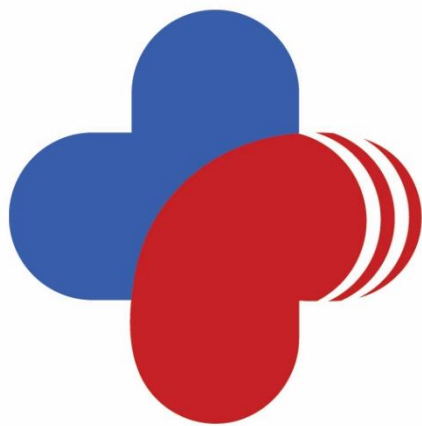

Clinical Scientist Equivalence Document

The SVT are in talks with The AHCS surrounding the design and development of an AVS equivalence document. The SVT would like The AHCS to recognise areas of the equivalence mapping template that are attained via AVS training, without the need to submit further evidence.

For areas not covered by the AVS training pathway, the SVT would like to be able to advice and provide examples of additional activities that an AVS could undertake to support their equivalence portfolio submission.

The SVT are also awaiting the final publication of the new STP curriculum (due Winter 2020) so that any documentation reflects the new programme.

The SVT are awaiting feedback from The AHCS regarding this project and hope to have more news in 2021.

AVS Research Module

No new developments with the proposed AVS research module due to COVID19. We hope to marry development of this module alongside the proposed Clinical Scientist equivalence review with The AHCS (see above) to ensure alignment of the research module learning outcomes with the equivalence mapping template.

The research module will become a mandatory part of the AVS training pathway, however to support qualified AVS in their equivalence journey we will also offer this project as a standalone module.

Once designed, the Education Committee will need to develop theory exam content at an item writing workshop to be included in the theory examinations.

Hopefully we will have more updates in 2021.

I wish to take this opportunity to thank all members of the SVT Education Committee for their time dedicated to the SVT, especially volunteering their precious time during a pandemic. I wish the new incoming chair of the Education Committee, Hannah Lines all the best over the next few years.

3 - SVT Research Committee Report 2020

SVT Research Grants

The SVT Research award is to enable Vascular Scientists to conduct small-scale studies such as pilot or feasibility studies, with the hope that larger grants will be applied for at a later date. There is a total of £10,000 available per year, with a maximum of £4,000 per award.

The SVT Research grants window closed at the end of March 2020. We received one application and I am pleased that Osian Llwyd, Oxford, was awarded a research grant.

As in previous years, if the full allocation was not awarded, then we had another window that closed at the end of September 2020. We had one application and are still in the process of review. The applicant will be informed in the near future.

We envisage the 2021 window will open in the new year and close at the end of March 2021.

The Vascular Priority Setting Partnership (PSP)

We have been continuing our work with the James Lind Alliance Vascular Priority Setting Partnership. This is a national project working with the to give patients, carers and vascular health professionals an opportunity to have their say in what they think is important for future research for vascular conditions. The project is led by a National Steering Group with representation from the key vascular societies, charity and advocacy organisations (including the SVT).

We have previously had question submission prioritisation by healthcare professionals. Patients and carers have submitted questions are there is an open survey for patients to prioritise these.

Looking forward, **BMUS ASM 2021** will be held in Cardiff City Hall from the 7th-9th December.

The SVT continues to work closely with BMUS, collaborating on Education and training content and other mutual professional interests such workforce planning and career frameworks.

BMUS, RCR and SCoR have continued to lobby for progress on obtaining statutory regulation for sonographers.

Recently the Department for Health/Department for Business, Energy & Industrial Strategy have launched a consultation: 'The Recognition of Professional Qualifications and Regulation of Professions: Call for Evidence'; regarding the need for professional regulation and is asking for input from individuals, institutions, employers and organisations.

BMUS have provided a response, working alongside CASE (Consortium for the Accreditation of Sonographic Education) and the CASE Chair, Heather Venables, to provide evidence from an educational accreditation stance.

The SVT has also responded to the consultation. We await further updates in the new year.

BMUS ultrasound guidance document will be updated and published online this December as is the annual custom.

The SVT were asked to provide our expert guidance for Lower Limb DVT scanning and Carotid and Vertebral artery Duplex scanning – both SVT protocols have shared and will be published within BMUS Guidelines for Professional Ultrasound Practice.

A recent report by Health Education England published on the 4th of November

'The NHS is set to radically overhaul the way MRI, CT and other diagnostic services are delivered for patients, a major report to NHS England'

Professor Sir Mike Richards was commissioned by NHS chief executive Sir Simon Stevens to review diagnostic services as part of the NHS Long Term Plan. The review's proposals will help save lives and improve people's quality of life including for cancer, stroke, heart disease and respiratory conditions.

With the impact of Covid-19 affecting many aspects of both professional and personal life it has been a difficult year for us all, but I am immensely proud of the response of all SVT members during this difficult time. From redeployment onto the front line to changes in service provision to ensure our patients and colleagues are kept safe, you have all done yourself and the profession proud. Well done.

I know this year's conference will be a lot different from usual but we hope it still provides you with all the usual insight, knowledge and networking that we usually benefit. A big thank you to our Conference Secretary Carole Tennison for her hard work in bringing this together in what was probably the most difficult year to be a Conference Secretary.

Education and Training

Back in March we took the difficult decision to stop both practical and theoretical exams and although a tough choice, it was the correct decision to ensure the safety of examiners and patients. Following the removal of lockdown restrictions, we were able to complete all theory exams in October and were also able to recommence practical exams. Good luck to all trainees who sat their exams this year and congratulations to all newly qualified AVS.

In order to align the SVT accreditation process more closely with the AHCS equivalence pathway we have been planning on reviewing the accreditation syllabus to include more research. Due to Covid-19 we have not progressed this as far as expected but hope to have a firmer plan ready for 2021-22.

Research

The SVT Research/Innovation award is to enable Vascular Scientists to conduct small-scale studies such as pilot or feasibility studies, with the hope that larger grants will be applied for at a later date. There is a total of £10,000 available per year, with a maximum of £4,000 per award. Many SVT members have already benefitted from these grants and we encourage all members to utilise this if they have any research/audits they wish to perform. Along with the grants the SVT research committee also has information and guidance available on the website for members wishing to write research proposals and grants, plus as a member of the SVT you gain free access to the European Journal for Vascular Surgery.

BMUS

The SVT continues to work closely with the UK's primary ultrasound society providing education and training at their national annual conference along with sharing protocols and guidance on vascular sonography for their members.

CASE (consortium for the accreditation of sonographic Education)

CASE is an organisation that exists to accredit sonographic courses delivered within the UK. The SVT works closely with CASE to enable this essential work to occur.

RAD-AID

The SVT is in discussion with the charity RAD-AID to create an award for an SVT member to provide free travel to help with their work in providing healthcare education and training in Africa, Asia and Central America. More information on the SVT/RAD-AID initiative will be available in the new year.

Membership Categories

The executive committee are in the process of changing membership categories to allow for a more streamlined and simpler categorisation that will also allow other professionals who share an interest in vascular science to join in some form and benefit from our guidance and protocols to help improve standards.

The process of changing membership categories will require a vote by the membership which will be announced at this year's SVT AGM.

Professional Registration and Lab Accreditation

This year the SVT introduced a compulsory register of AVS on our website enabling employers to quickly and easily get verification of a member's AVS status. Along with the SVT register there are also registries open for AVS within the SOR and AHCS.

Vascular Lab accreditation with the UKAS IQIPS scheme is still to see its full potential with only 3 vascular labs currently achieving accredited status. It is something the SVT Exec Committee is keen to improve and is going to be working with both UKAS and our members to help more labs gain accreditation.

The year ahead...

The year gone by presented numerous challenges that I had not thought possible when I took the reins as president back in the non-Covid days of November 2019. This meant a lot of the

plans I had for the society needed to be put on hold this year however with the distant hope of normality on the horizon I am determined to push ahead with our plans in the coming year.

- In the next 12 months, I aim to produce a survey on workforce planning which will hopefully give us an idea of any potential future issues regarding staff levels.
- Following the success of online zoom/teams based virtual meeting this year we are looking to utilise this technology for future study days and revision sessions.
- RSI is as always, a major risk factor in our profession and the last survey on this was a number of years ago so I plan to produce another RSI survey plus provide online resources for our members.
- The SVT RadAid global health initiative will launch in 2021
- Mental health and wellbeing is an important aspect of overall health and following the year's events is as important as ever. I look to increase the resources we offer for our members to help with any of these issues and potentially offer training.
- Promote IQIPS accreditation and work with the accreditation board to help more vascular departments achieve the standards necessary.

At the end of a difficult year we start to look forward to a better 2020-21 and with hope of the meeting in person again at the November 2021 SVT Conference.
